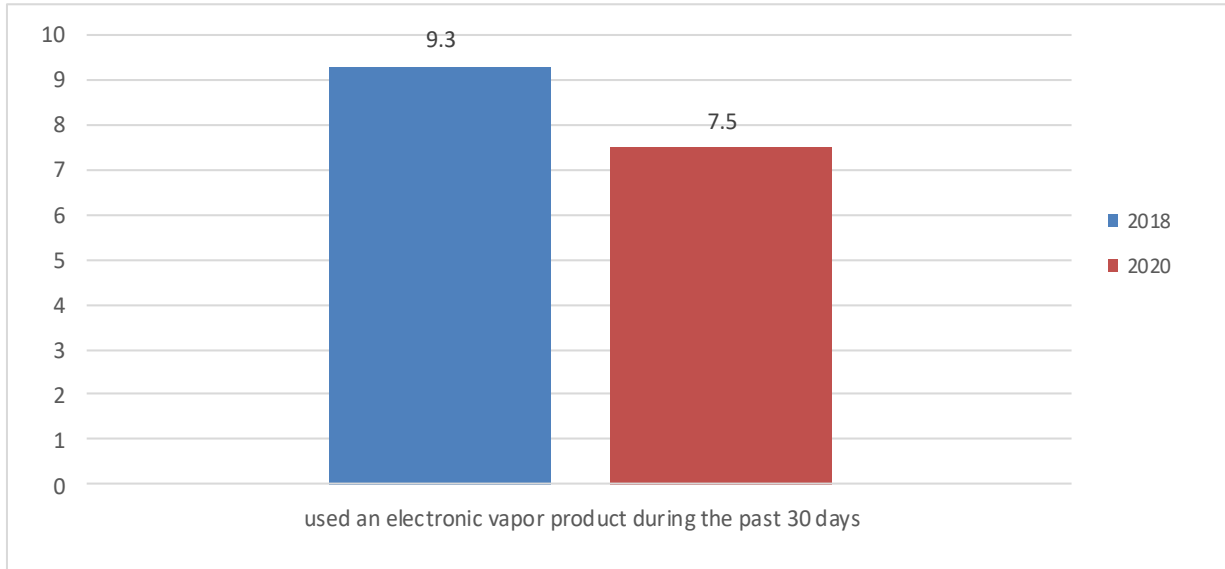


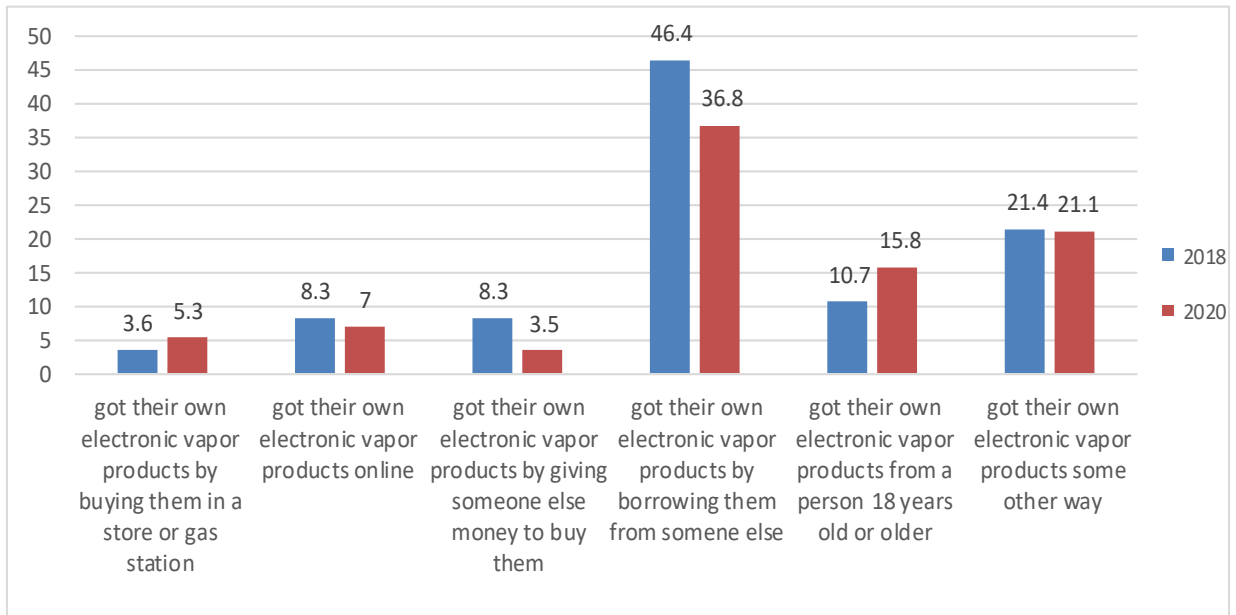

% OF ENDS YOUTH ACCESS—7th Grade

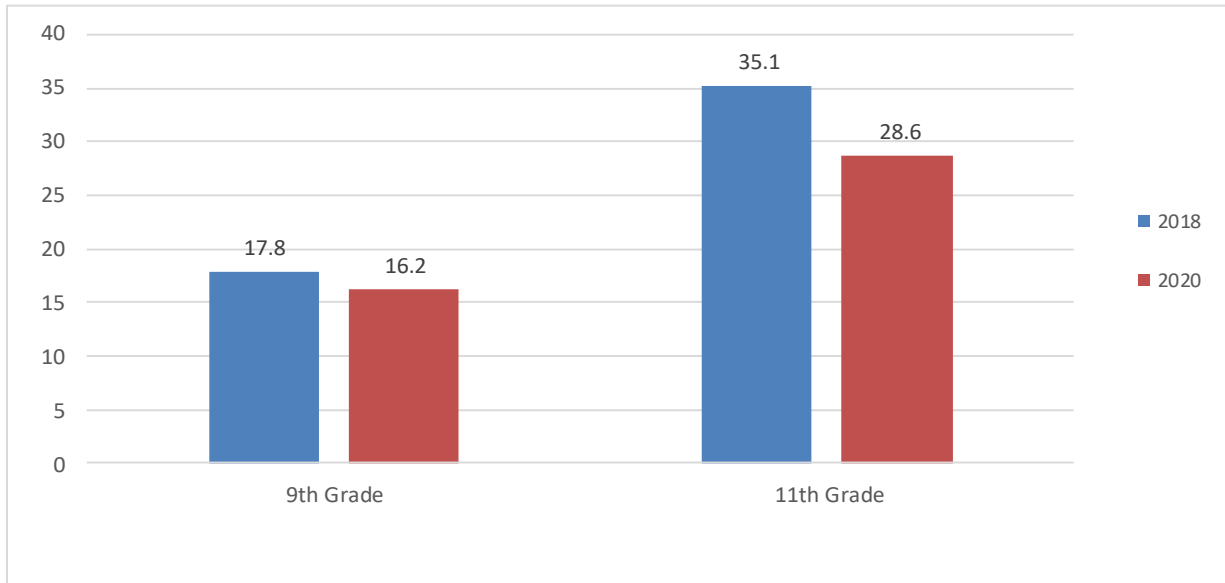

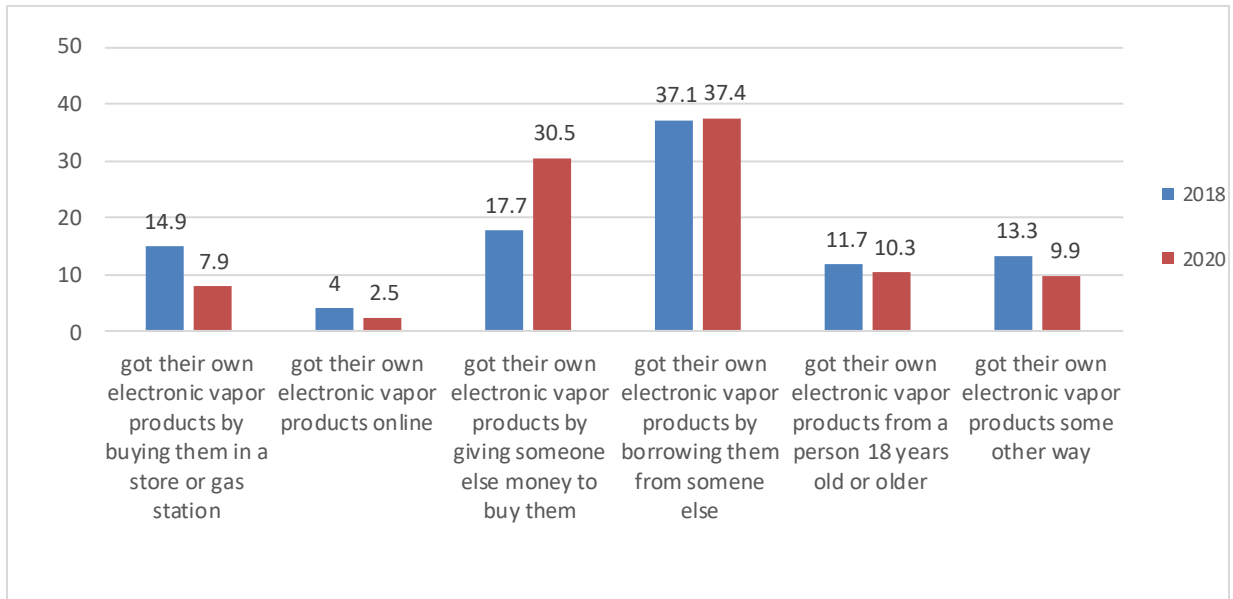

% OF ENDS YOUTH ACCESS—9th & 11th Grades



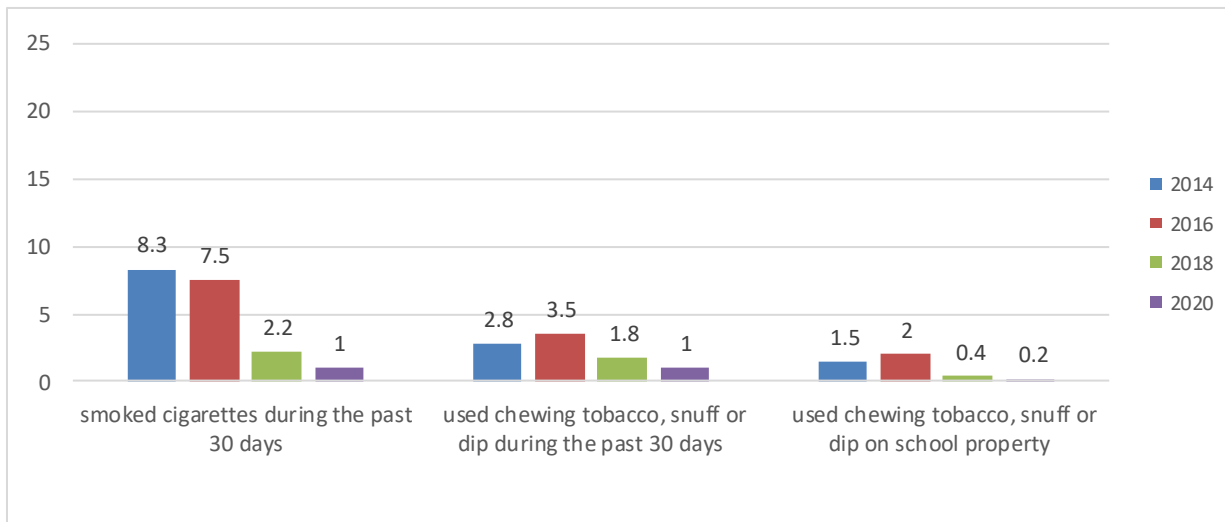

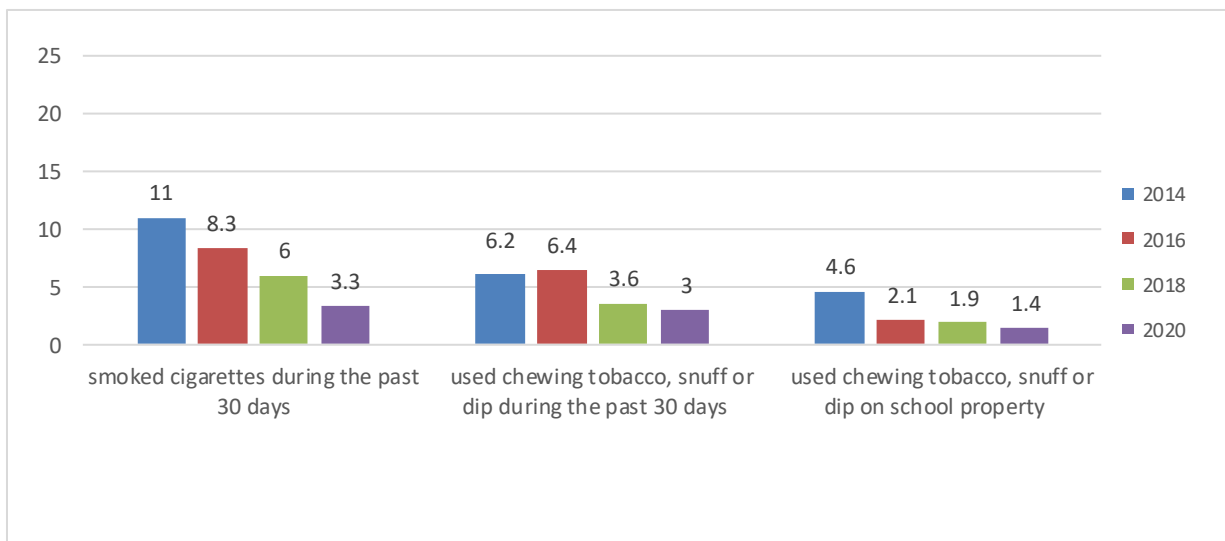
More than 1/3 of all youth who ever tried smoking a cigarette become regular, daily smokers before leaving high school. *Center for Disease Control and Prevention (CDC)

Use of e cigarettes are not a safe alternative to other forms of tobacco. As of August 8, 2016, the U.S. FDA imposed a minimum purchase age of 18 for selling to minors.

% OF TOBACCO 30 DAY USE (11th Grade)

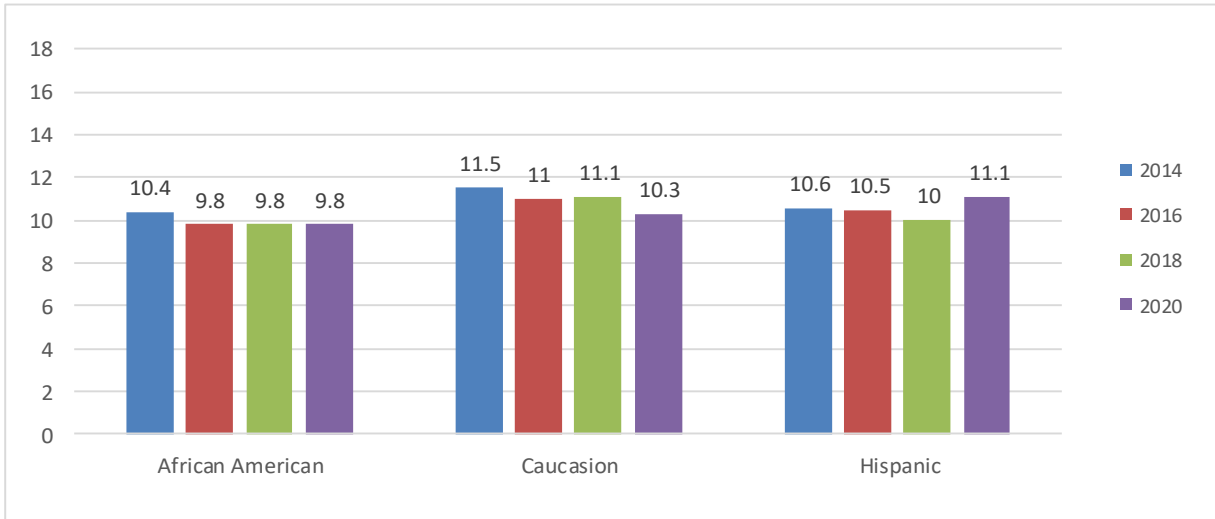

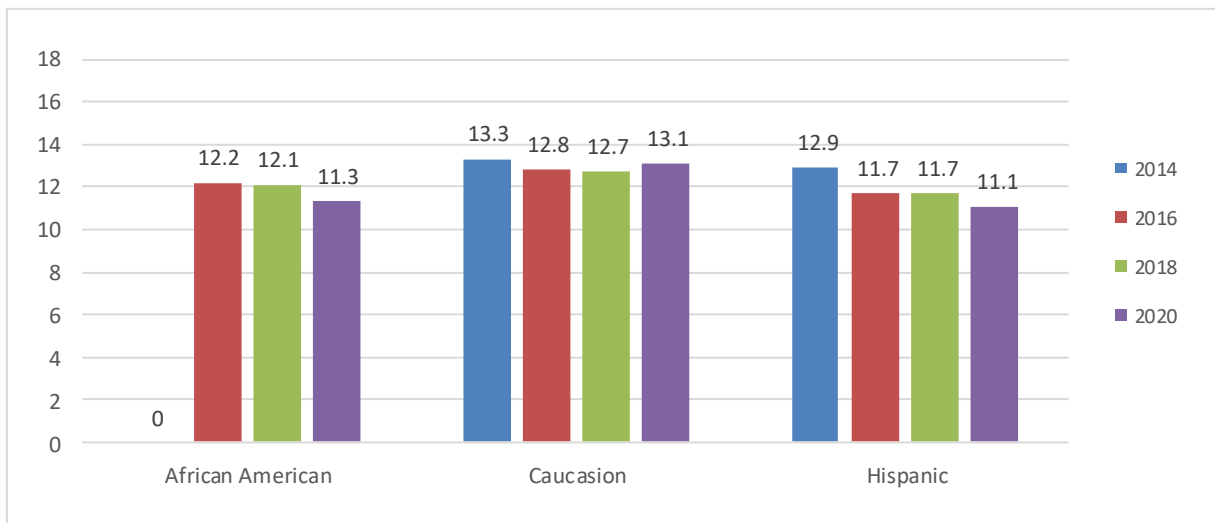

AGE OF ONSET—(9th and 11th grades)



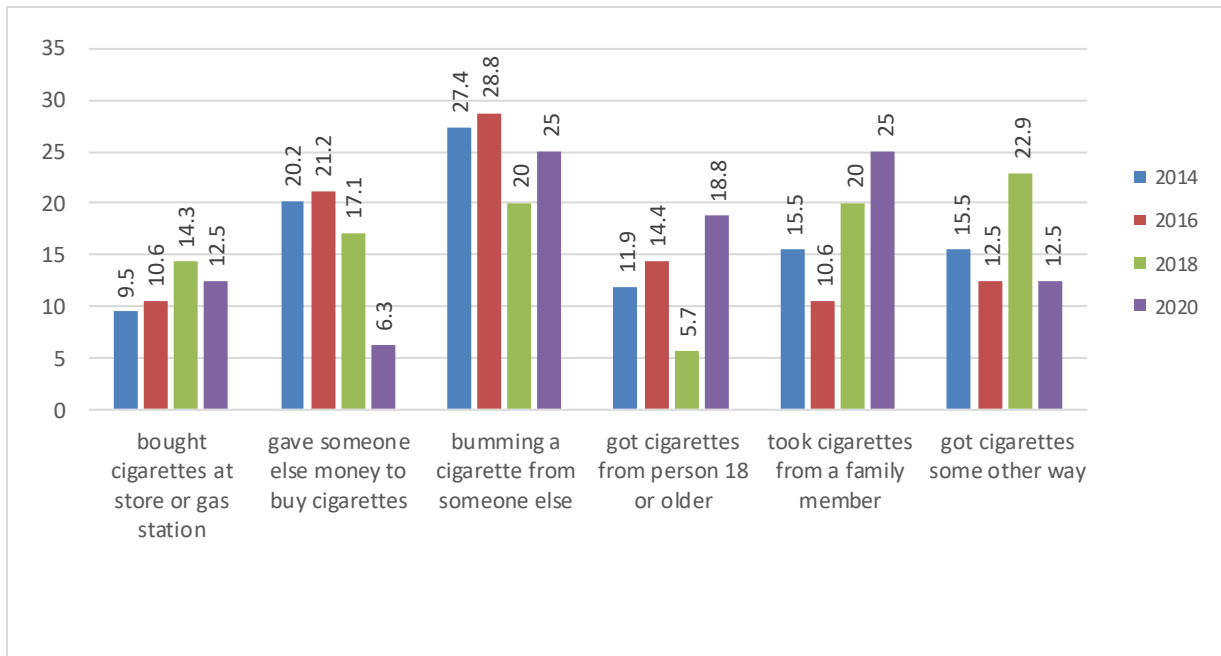

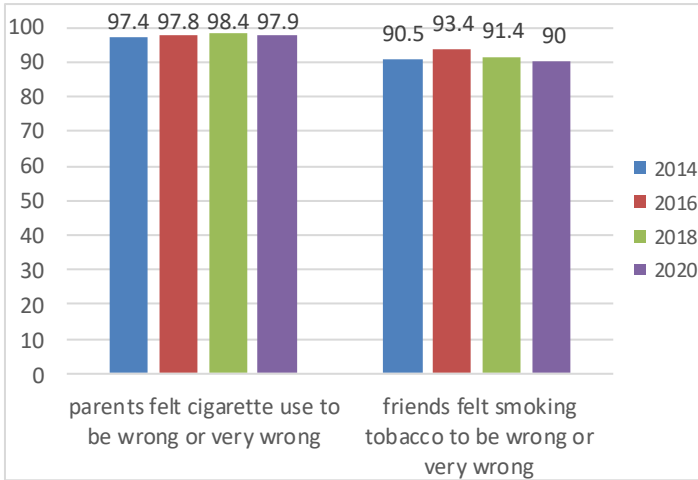
% OF YOUTH ACCESS—(9th & 11th grades)



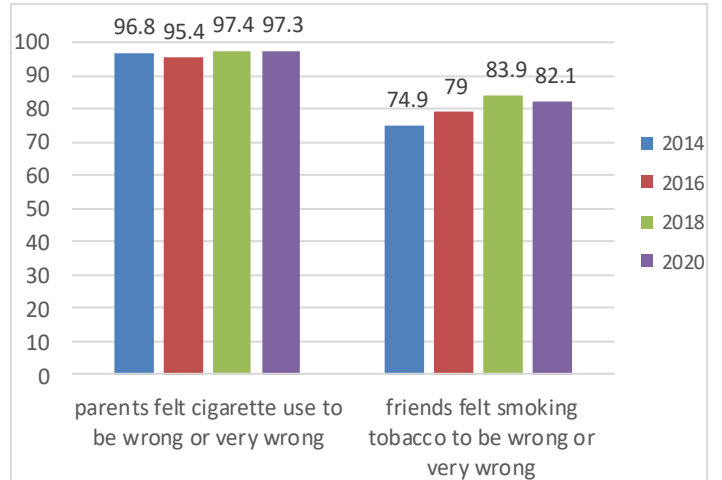

% OF PERCEIVED RISK AND PERCEPTION OF DISAPPROVAL-(7th grade)



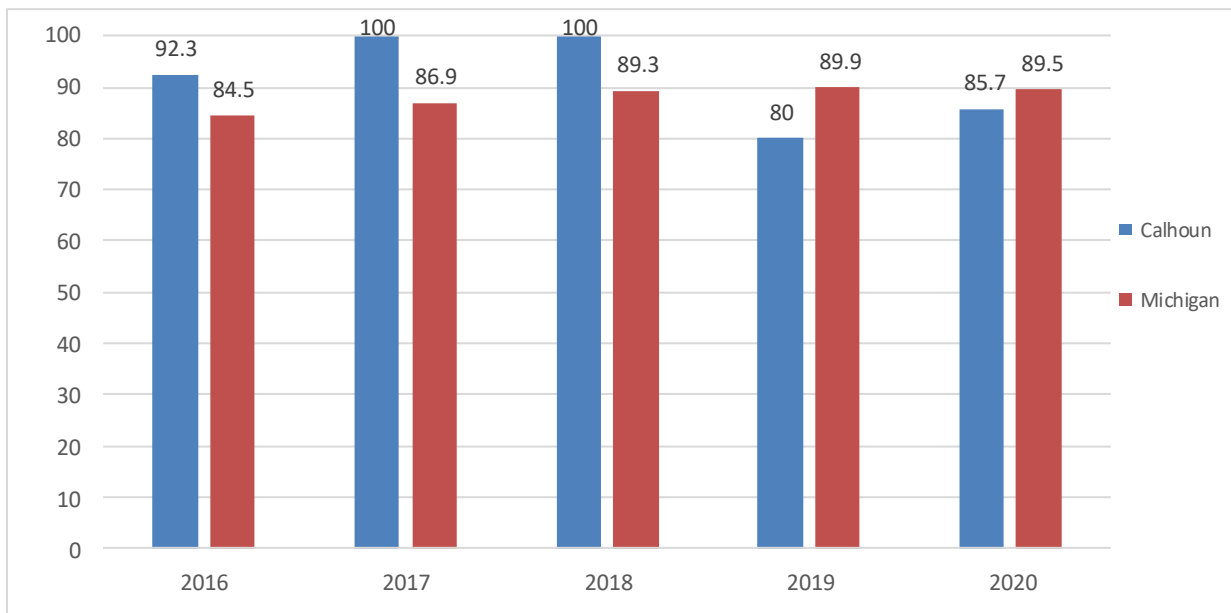
% OF PERCEIVED RISK AND PERCEPTION OF DISAPPROVAL-(9th & 11th grades)



The federal SYNAR Amendment requires states to have laws in place prohibiting the sale and distribution of tobacco products to persons under 18 years-of-age and to enforce those laws effectively. The annual SYNAR reports detail trends in sales of tobacco to minors and the success of compliance with SYNAR amendment.

Illustrated in the chart below is Calhoun County and Michigan's SYNAR compliance rate for underage tobacco sales through 2019.
